# **<u>1. EXECUTIVE SUMMARY</u>**

# **1.1 INTRODUCTION**

Acharya Sukumar Sen Mahavidyalaya,a co-educational institute of higher education, is located at the village Gotan in the block Raina –II of the district of Purba Bardhaman, West Bengal. The college is situated within the periphery of one of the highly fertile agricultural belts of rural Bengal. The college was founded in the year 2013 by the generous and enthusiastic people of the locality with the able leadership of renowned social worker Dr. Tusharkanti Pal and patronized by Mr. Pradip Kumar Mazumdar presently Minister in- charge , Panchayat and Village Development , Government of West Bengal. The college,affiliated to the University of Burdwan, got its permanent affiliation from the University in the year 2018. Since its inception the college aims at providing value based education to the rural youths many of whom are first generation learners and come from the backward community so that the young generation of the society become intellectually sound equipped with moral values. Our students would be socially concerned and spiritually oriented.

The college offers 6 UG Courses with 10 different subjects of Arts stream and aspires to deliver quality education to the students. This co-educational institute is represented by students from both the genders and every student is a prize possession of the institute. The college management comprises of the Governing Body and is constituted by the President, Principal (ex-officio secretary), representatives of both teaching and nonteaching staff, one student member and some external members nominated by the state government and the affiliating university. The Governing Body decides all pertinent issues of the college for policy formulation and the Principal as the Head of the Institution performs all the academic and administrative functions.

A number of constituent bodies send recommendations to the Governing Body for decision making so that a steady governance is maintained. Within a span of only ten years of its establishment the college boasts off its achievement for assisting local students to the path of their pursuing higher education. The college extends its support to the students in all possible ways and welcomes the students to come back as its proud alumni.

Catering quality education and training among young generation to make them intellectually sound, selfreliant, compassionate human resources so as to future leaders of the nation by fulfilling their educational passion through value based education. The college not only aims to impart contemporary education to the students but also puts equal importance on co-curricular activities so that they become versatile in all of their future endeavors. The institute promotes social and moral values among the students and is dedicated to create an environment of alround development of the students. The college aspires to overcome its limitations for the betterment of its students.

- 1. This is the only institute of higher education of the block having full support from the local people who contributed lakhs of rupees for the construction of the college building.
- 2. The NSS unit of the college conducts various programmes throughout the year.
- 3. The college administration always helps in the alround development of the college and provides full support.
- 4. Students of the Yoga and Physical Education departments perform various cultural programmes regularly.
- 5. The college has a pool of qualified and dedicated teachers and active support staff.
- 6. The college has its playground and mini indoor stadium to promote games and sports among the students.
- 7. Awell-equipped gymnasium and UGC- sponsored Certificate course in Yoga.
- 8. Welfare schemes for both teachers and students like Employer's Co-operative credit society, scholarships from NGOs etc. are operative.
- 9. With total support from the management and staff our college maintains communal harmony.
- 10. Our institute encourages research and professional development of its staff.
- 11. Installation of CCTV cameras at places of strategic importance for continuous surveillance.
- 12. Regularized scholarship system for the students.
- 13. Airy and spacious classrooms.
- 14. Spacious seminar hall with audio system.
- 15. Separate common room for boys and girls.
- 16. Students are encouraged to design departmental wall magazine and college magazine.

#### Institutional Weakness

- 1. Shortage of teaching staff and Librarian.
- 2. Lack of funds for infrastructure development.
- 3. Insufficient classrooms and space.
- 4. Lack of ICT—enabled classrooms and insufficient number of computers.
- 5. Being located in remote rural area with insufficient transport facilities roll strength is not upto the mark.
- 6. Students mostly come from under privileged backgrounds and a large number of them are first generation learners.
- 7. A few of our students often tend to settle for less paying jobs by dropping out of the college due to their economically challenged backgrounds.
- 8. The college requires more teaching staff in certain departments so that the students may be benefitted.
- 9. The institution also lacks a functional canteen.

#### **Institutional Opportunity**

- 1. The college plans to introduce non- conventional subjects and a few relevant vocational courses.
- 2. The college aims to expand its collaboration with other institutions.
- 3. The college plans to offer more services to the society by engaging students through extension of NSS activities.
- 4. The college aims to make complete green campus after completion of construction of the college boundary wall.
- 5. The college plans to introduce a faculty research grant.
- 6. There is a provision of online study materials for the students which they can avail through college website.
- 7. Students council co-operate with the college authorities in all activities related to the best interest of the students of the college.
- 8. Faculties work hand in hand for the betterment of the institute.
- 9. The campus is ragging-free. Students are made aware of the anti-ragging mandate in the very induction programme for the newly admitted students every year. The same is also available in the college website.
- 10. A number of welfare committees like Women's cell, ICC, Grievance Redressal Cell etc. are formed for maintaining efficient governance.
- 11. Faculty members of the college are always ready to take administrative responsibilities.

# **1.3 CRITERIA WISE SUMMARY**

#### **Curricular Aspects**

Acharya Sukumar Sen Mahavidyalaya is an affiliated college under University of Burdwan and is strictly adhered to the syllabus as specified by the University. CBCS system for under graduate courses has been adopted by the University since 2017. The college offers undergraduate courses (Honours and General) in various humanities subjects. The syllabus is distributed rationally among the faculties well in advance of each academic session. The college takes care in distribution of class routine among the students and staff. The mentor-mentee system is operative for every Honours Students and all the departments submit reports to the IQAC. The central library of the college is equipped with computer and internet facility. The college offers two ICT- enabled classrooms with projectors. Several departments organize field trips and local excursions. The institute encourages staff members to participate in seminars, workshops and conferences. Faculties are motivated to participate in induction programs, refresher courses and orientation programmes. NSS unit of the college conducts awareness programmes and extension activities. The structured feedback on the curriculum has been collected from the stakeholders and placed before the Governing Body for necessary action. Feedback

analysis and action taken report are displayed on the college website. The college follows the academic calendar as specified by the University and as and when University notifies any information the same is communicated to the students.

The college has signed MoUs with a number of academic institutions for faculty and student exchange programmes as well as seminar and other academic achievements. Teachers in the college actively participate in University examinations. One of the faculties has participated in FLT programme in USA. One of our teachers are now acting as Ph. D guides.

#### **Teaching-learning and Evaluation**

The teaching - learning and evaluation system of the college focuses on inclusive and quality education. The entire admission process is carried by online mode as per directives of the University and also in observance of reservation policies of the Government. The college follows the merit based admission. Every academic session starts with an induction program. Course outcomes are available in the college website. There is a provision of remedial classes. Field trips and excursions are undertaken by a number of departments. The mentoring policy of the college involves all the teachers covering each and every student. The college has adopted various learning processes like peer teaching, remedial classes and field - based projects. IQAC of the college has prepared the POs and COs of the University syllabus. Each UG department has prepared COs of all courses. Internal assessment is carried out on the basis of students attendance, project works and class test. Any grievance relating to examination is dealt with utmost care and examination committee looks into the matter for necessary action. The institution practices analysis of results for each department. Average pass percentage of last five years is 83.30 %. The college authority puts emphasis in filling up vacancies against sanctioned posts in order to maintain decent student - teacher ratio. The college focuses on student - centric methods like experimental learning through study tours, field visits etc. For effective teaching - learning process the IQAC insists on use of ICT, E-resources and power point presentation. A bunch of qualified teachers always assists our students for their all-round development. Students get help from well- maintained library having Eresources.

#### **Research, Innovations and Extension**

The College encourages faculty members to participate in research activities. Although not in the span of the present evaluation period, it will be worth-mentioning that three UGC- sponsored research projects have been completed by two of our faculty members. One of our teachers participated in FLT programme in USA. One of the faculty members are now engaged in guiding research students. Many faculties have also registered themselves for Ph.Dprogramme with other Universities.

#### A glimpse of the research activities of the faculty members of the college is outlined below:

Number of teachers registered for Ph.D -

Our teachers have participated in about fifty National / International and State level seminars / webinars / conferences. The college has also organized more than twenty National/ International and State level seminars / webinars during the last five years. The college also organizes students seminar on various important issues like IPR, Gender sensitization,Student credit card etc. The career counseling cell of the college have organized a number of programs.

The NSS Unit of the college performs various extension activities on a regular basis in neighbouring areas. The volunteers participate in cleaning the campus and adopted village, organizes awareness camps and rallies on various social issues and challenges. The students of the Physical Education Department have performed stage shows on social issues in local platforms. Our academic departments participate equally to make the students aware on gender issues and importance of international days etc.

#### Infrastructure and Learning Resources

Acharya Sukumar Sen Mahavidyalaya provides infrastructural facilities as per requirements of the CBCS curriculum and instant need of the students. The college has a three- storied building with total built- up area of 7055sq. ft.,housing 15 classrooms, one laboratory for Geography and one for Computer, one seminar hall, and two separate common rooms for boys and girls. Basic amenities like water filters, clean toilets and wash basins etc. have been provided by the college. To reduce the cost of electricity the college has installed solar panels. The college has a motor cycle / cycle stand and a well-maintained children's park. There is a pond of 45240Sq.ft. at the middle of the campus. The college has a spacious library of 783 Sq.ft with sufficient reading space (270 sq. ft.). It has library software. Average annual expenditure for college library during last five years is Rs.41867.80/- The college has excellent infrastructure for sports and co–curricular activities. There is a play ground of 64110 sq.ft area, an indoor stadium of 1330 Sq.ft.and a well-equipped gymnasium. There are table tennis and carom boards in the list of college indoor games. Our students participate in University and college sports every year. The college has musical instruments like harmonium, tabla and drums.

There are two ICT- enabled classrooms in the college. An average of expenditure excluding salary component for infrastructure development during last five years is Rs.1626147.80/-. Average expenditure incurred on maintenance of infrastructure (mini generator, water purifier, servicing of computers and academic support facilities) excluding salary during last five years isRs.220629.40/- of the total budget. CCTV cameras have been installed at strategic location of the campus.The college has made provision for a reading space adjacent to the library. In spite of all those efforts the college has genuine limitations in infrastructure and learning resources which is the major hindrance in its smooth running. The college always tries its best to overcome all the hurdles in order to upgrade its existing rsources.

#### **Student Support and Progression**

Students are the prize possession of an academic institution and as such it has been the primary duty of the institution to serve this most important assets to the best of its abilities. Acharya Sukumar Sen Mahavidyalaya provides holistic education by nurturing academic as well as extra-curricular talents of the students. The college has a well organized monitoring and support system for the students. The college strongly follows the reservation policies of the Govt. during admission of the students. It monitors timely implementation of various scholarships for the students. The college has organized a number of career counseling classes for the students

in order to guide them for competitive exams. The college has formed a number of committees like anti-ragging committee, grievance redressal committee etc. The college upholds zero tolerance policy for sexual harassment and has a very strong disciplinary committee headed by the Principal. The institute maintains a feedback system for retrospection and future development. Under the able guidance of mentors students organize different cultural and sports events and actively participate in Saraswati Puja and Observation Days. The college magazine Ankur and wall magazines of individual departments reflect literary skills of the students. The college annual sports is organized every year where students participate in different events from races to long jump. Our moto is to provide them every opportunity to explore their talents in various fields for a bright future.

#### Governance, Leadership and Management

The Governing Body, headed by the President, is the highest decision making authority of the college which includes the Principal as the ex- officio Secretary, representatives from teaching and non- teaching staff, student's representative and a few external members selected by the affiliating University and the Govt. of West Bengal.

All sorts of academic, administrative and financial decisions are collectively taken by the Governing Body and Principal of the college is empowered to execute all functions. The Governing Body considers all the suggestions and recommendations coming from the office of the IQAC, Finance Committee and other subcommittees. All agenda and resolutions of the Governing Body meeting are always recorded meticulously. The college practices the system of decentralized management with active participation of academic council, Teacher's council and Student's council.

The college supports its stakeholders by providing advance payments of newly recruited teachers and nonteaching staff till their salary fixation is done. Casual workers are paid from the college fund. Both external and internal audits are done on regular basis to maintain transparency in financial matters. The IQAC of the college plays very supportive role in guiding the institution in teaching- learning processes.

#### **Institutional Values and Best Practices**

Acharya Sukumar Sen Mahavidyalaya is committed to impart quality education. Under the able guidance of the Principal, the college aims to uphold the core values among all the stakeholders. The college wants to create an inclusive environment and free from all biasness.

# **1.1 Curricular Planning and Implementation**

## 1.1.1

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

#### **Response:**

As a constituent college affiliated to the University of Burdwan, the institution does not directly participate in framing of the curriculum and follows the syllabus prescribed by the University for undergraduate studies. The institution ensures listing and sequencing of topics and clarity, accuracy and appropriateness in topic presentation. Special emphasis is given on topic delivery and completing in proper frequency with depth and space. The faculty focuses on conceptual ideas and puts emphasis on integration of the whole structure. Stress is given on analytical approach, communication and reflection in proper way. Although the institute strictly adheres to the Academic calendar set by the University, institutional academic calendar is prepared at the beginning of an academic year. It contains annual programme chart displaying number of working days, holidays, probable list of institutional programs, tentative schedule of internal assessment and University examinations. It also includes probable list of institutional programmes and activities for the academic year. The college prospectus gives necessary information regarding admission, CBCS, individual department and general rules of the college administration. The new pattern of syllabus as per NEP has been integrated in the college prospectus from academic session 2023-24 onwards. A master routine is prepared by the Routine Sub- committee and classes are held as per the schedule of this routine. The routine is displayed on the college notice board and is distributed among the teachers and the students.Each department follows well-structured individual departmental time table. The faculty keep on recording classes taken, leave and extra curricular activities in a special self- appraisal book which is regularly monitored by the IQAC and Principal of the college. Faculties are encouraged to participate in ICT- based classes as per the master routine .Departmental meetings are held regularly to monitor academic and administrative issues and each department maintains meeting resolution book for proper execution of the curricular aspects. The institution has arranged online feedback from various stakeholders and the feedback analysis has been submitted to the IQAC for taking necessary action. The central routine and departmental routines of the college show honours and general classes as well as classes of core course, generic elective and ability enhancement compulsory courses under CBCS system. The routine shows room number and name of the teacher for each class. Various committees of the college continuously monitor academic and administrative activities. The IQAC also invites feedback from the students regarding implementation of the curriculum. The curriculum is accordingly distributed among the teachers and lesson plan is submitted. The institution has adopted various modes of assessment like class test, internal and external assessment, seminar presentation and home assignments. It has also adopted different teaching methods such as lecturing, group discussion, seminar presentation, project work, use of teaching aids etc. Our faculties have adopted high tech approachof curriculum delivery through Google meet, Google Classroom and WhatsApp at the time of Covid—19 pandemic. In the classroom students are encouraged to identify critical topics for review and to develop questions as well as to share the learning process and content

The college is affiliated to The University of Burdwan and follows the syllabus as framed by the parent university. However, within the parameters of the syllabus, classroom teaching of the institution integrates major crosscutting issues like gender, professional ethics, human values and environmental uses. These issues are also addressed in student participation in seminars/webinars.Almost all the department have wall magazines where student are encouraged to write on social issues and environmental issues like health and hygiene,biodiversity conservation etc. They are also encouraged to make posters on those issues. Project work on environmental studies provides practical knowledge on the environment and issues related to environment.The English major syllabus includes texts like domestic violence (Bravely Fought the Queen) and gender equality (Theories of Feminism/ Clear Light of Day) that would make the students aware of progressive ideas.

#### **Response:**

Student centric methods, such as experimental learning, participative learning and problem solving methodologies are used for enhancing learning experiences. Our approach focuses on following points

One of the first steps in Student centric learning is to encourage students to participate in peer teaching. Extension lectures are organized where academicians from other colleges are invited to deliver lectures so that students of our college have a wider exposure to different modes of teaching. The college has two virtual rooms with computers and projectors.

Students regularly participate in Youth Parliament in which they are trained to speak on a variety of topics.

Students of Physical Education Department performed stage shows on various social issues which bring out their hidden talents and break stage nervousness. Almost all the departments have wall magazines that bring out the talent and creativities of the students. They contribute poems, articles, photographs etc.

The Career counseling cell in collaboration with IQAC organized a number of programmes on career guidance which inform them about the latest opportunities. Mentors help the students to combat life style issues and act as counselors of stress management.

Development of soft skill is the need of the day. Department of Yoga train the students to develop soft skill. Faculties encourage the students to write projects. Local excursions are conducted by the department of Education and History in places of historical importance. Each year students of our college are encouraged to participate in college and university sports.

Seminars and conferences in both offline and online modes are organized regularly by most of the departments where scholars from Universities and other colleges deliver talks.

At the time of COVID- 19 pandemic the college adopted total online mode of teaching . During exam hours students were provided with all sorts of assistance so that they could submit their answer scripts through online portal.

# 2.5.1

# Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

#### **Response:**

Being an affiliated college the external/Semester examinations are conducted under the control of the affiliating University. From online form fillup to generation of admit card for the examination is done through University web portal. Students sit for examinations in away Centre. However, the Examination Sub- committee consisting of senior teachers and non- teaching staff of the college monitor the whole process. During pandemic hours the examination modalities were completely changed and the exam. Sub—committee performed the University exams within the college campus through online mode with a great sense of responsibility. Evaluation of answer scripts were done by the subject teachers under the directives of the affiliating University. Marksheets/ Results are also downloaded and printed from the University web portal.

Grievance related external exams are dealt with utmost care. Any grievance during the University exams is first taken up the Exam. Sub—committee and proper steps are taken immediately. If any discrepancy regarding registration, form fill up, generation of admit card or marksheet is observed, Principal immediately forwards all applications to the Controller or Registrar of the University.

The students can apply for reassessment or scrutiny of answer scripts through University portal. Students can also apply for a copy of the answer script as per the RTI Act. The College handle the exam related grievances in a transparent and efficient manner.

Internal evaluation and class test related grievances are dealt with Grievance Redressal Cell of the college. The Exam. Sub—committee resolves the problem by holding a meeting with the complainant and the department concerned. Notices of the upcoming internal examinations are served regularly and well-ahead of the exam schedule using college notice board and online platforms of the teacher—student interaction of the college.

In fact, grievances related to internal assessment has been reduced almost zero percentage because of the fact that the evaluated answer scripts are shown to the students in most of the times. The institution adopts a precautionary measure in which teachers explain the students the CBCS system and methods of evaluation to be followed at the beginning of each academic session. This minimizes the chance of misunderstanding and probable grievances, if any. Supplementary tests ar also arranged if necessary.

### **3.2 Innovation Ecosystem**

#### 3.2.1

Institution has created an ecosystem for innovations, Indian Knowledge System (IKS), including awareness about IPR, establishment of IPR cell, Incubation centre and other initiatives for the creation and transfer of knowledge/technology and the outcomes of the same are evident

#### **Response:**

Students and faculties of the Institute are interwoven in an ambience of reciprocal exchange of ideas and thoughts for overall quality improvement. The ecosystem created by this way generated an environment of initiatives of green campus, regular green audit, installation of solar panels, use of energy-saving LED and CFL and constant encouragement of the office staff to use less cartridges and paper works. Power generated by the solar panels meets the demand of the institute and the surplus amount is transferred to the grid that would help to feed the locality.

Various ICT enabled technologies like projectors, desktops, lap tops, printers and Bluetooth speakers are employed to delivers lectures. The Seminar Hall of the institute is ICT enabled and there are also two smart classrooms in the college. Faculty members use the smart classroom to enhance the teaching and learning process. Teachers post e-resources on the web platform to aid in teaching and learning. During Covid-19 pandemic period i.e. academic year 2020-2021, regular classroom teaching could not be held and faculty members were forced to adopt online teaching modes by using mobile phones, Tablets, laptops and desktops. They continued their classes through online platforms including WhatsApp, Google

classroom, zoom etc. and provided study materials regularly on the web portal. Online class tests were also conducted. A number of departments have conducted webinars in collaboration with the IQAC of the college.

As far as multidisciplinary approach in concerned various departments of the college have been organizing interdisciplinary lectures by inviting faculties from other departments. In order to meet the demand of shortage of faculty, Teachers of Education department have taken classes of the students of philosophy subject.

An incubation center has been developed at the library for guidance of the students in competitive examinations. Various cross cutting issues like gender equity, human values and ethics and environmental sustainability are dealt with the courses offered by the institution. Seminar on the Intellectual Property Rights Organized by the department of Education of this college in association with the Internal Quality Assurance Cell on 14.12.2022 leads to establishment of IPR cell in near future.

In order to generate public awareness, NSS Unit-1 of the college organized different awareness programs like a traffic awareness rally on 07.06.2022, No Tobacco Day celebration on 31.05.2022 and blood donation camp on 29.02.2020. Tree-Plantation program on 19.07.2022 and International Yoga Day on 21th June 2022 were also observed.

Regarding academic activities, the strategy is effectively deployed by the preparation of lesson plans and academic calender. An annual budget is prepared for allocation of funds for all inclusive activities. Utilization of funds is monitored by the Financial Committee and Governing Body of the college.

Governing Body is the premier body in the administrative hierarchy and it is the policy-making body of the institution. The college is governed by different administrative set ups as specified by Department of Higher Education, Government of West Bengal and the statute of The University of Burdwan. The Principal is the ex-officio Secretary of the Governing Body and executive head of the institution. The Governing Body is represented by members from teaching, non-teaching, students, as well as nominees of the state government and university. The Principal acts as the president of the Teachers' Council and the Chairman of IQAC of the college. IQAC formulates and monitors all the strategic plans and proposals. Financial transactions are checked by the Bursar with the help of Accountant. The Principal also acts as ex-officio secretary of all Academic Committees, Financial Committee and office administration. In fact, The Principal acts as a liaison between the management and staff. He executes all the decisions including financial matters taken in the Governing Body. A team of support staff including Bursar, IQAC Co-ordinator, Departmental Co-ordinators, Secretary of Teachers' Council and Accountant assist him in day-to-day functioning of the college. A number of academic and administrative sub-committees have been set up to look after all the matters related to finance, building, construction, renovation, maintenance and academic interest of the college. Some of the important subcommittees include Finance, Building, Anti-Ragging Squad, Grievance Redressal Cell, IQAC, Academic, Sports etc.

The inistitution has specific strategies for mobilization and optional utilization of fund for infrastructure development and Student welfare.

#### **Mobilization of Funds:**

The major source of funds during the last five years has been received from the Higher Education Department, Government of West Bengal.Funds are also mobiliged from fees collected from students.The College solicits grants from M.P/MLA LAD.Funds are also generated from government agencies, private donations, NGOs etc.

#### **Utilization of Funds:**

For proper utilization of funds the College has framed a Finance and Purchase Committee,Building Committee and Library Committee.Funds are allocated as per requirement and recomendation of these committees.Finally,allottment of funds are reviewed by the Finance Committee and ratified by the Governing Body.

#### There are two different types of expenditure:

1. Recurring

#### 2. Non-recurring

Recurring expenditure involves daily expenditure.A major part of the annual income is spent for

students' cultural programmes, annual sports, organizing seminars, payment of remuneration of Casual Staff etc.On the other hand, non-recarring expenditure involves long-term augmentation and mainteinance of infrastructure including purchase of Library books, furnitures, Computers, Electrical goods etc.In order to meet the expenses, the college has applied to the Govt. for more funds from time to time.

Fees collection from the Students are utilised for the development of the College and Finance & Purchase Committee determines the policy and procedure of all kinds of purchases. Purchases of goods is done through tenders. At least three tenders are collected from different vendors and compared for purchasing any iteam and every transaction is supported by bills / vouchers. All collections are deposited in the bank and expenses are incurred through cheques/electronic mode. Bills / vouchers are processed by the accountant, Bursar and Principal of the College.

Both external and internal audits have been completed. External auditor is recruited by the Department of Higher Education, Government of West Bengal.

#### 6.5 Internal Quality Assurance System

#### 6.5.1

Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes. It reviews teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals and records the incremental improvement in various activities

#### **Response:**

The Internal Quality Assurance Cell (IQAC) of the college is instrumental in maintaining the quality of teaching learning process and overall development of the institution from the very beginning of its inception. IQAC conducts regular meeting to examine various aspects of teaching learning process and all-round development of the college. IQAC in collaboration with various departments has regularly organised seminars/ Webinars of which seminar on Intellectual Property Right, held on14.12.2022 and Gender Studies, held on 05.11.2022 need to be specially mentioned. IQAC has introduced structured feedback system in the college from the session 2018-19. Regular analysis of feedback is done and the same is reported to the Principal for further action. A number of add-on/certificate courses has been introduced by the IQAC as supplementary programme to the basic curriculum framework. From the session 2018-19 till date as many as 16 such courses have been completed. Participation of students in these courses is quite satisfactory. IQAC has always been functional to maintain a green campus and plantation has been done throughout the campus. Not only that a flower garden and a medicinal plant garden has also been set up within the campus. In modern educational System, mentor-mentee framework is the backbone of teaching-learning process. In collaboration with the academic committee IQAC has established mentor-mentee system in the college. It helped a lot to solve any problem arising

in regular college hours. IQAC paved the way for installation of CCTV camera at some places of strategic importance within the campus. IQAC resolved to introduce automation of the college library and new software has been installed from the session 2022-23. IQAC has introduced Academic Audit and Green Audit from the session 2020-21 and the same will be followed in coming years. IQAC has always looked forward for collaborative exchange with other institutions. Faculty exchange programmes has been done under the umbrella of MoU signed between Acharya Sukumar Sen Mahavidyalaya and various higher educational institutes. Alumni Association is one of the foundation stone of the academic institute. In our college, an alumni association existed since 2019 but it was not registered. The association was registered in the year 2023 by the active initiatives of the IQAC.

#### 4. The Practice:

The Institution has set up a committee for Value-Based Education. Members of the committee take part in meetings held at regular intervals. A roster is prepared at the beginning of each semester showing the names of the teachers who have been allotted classes on Value-Based Education. The same roster is displayed on the student's notice board and also on the notice board of the Teachers room. Variety of topics covering environmental awareness, moral values, health and hygiene, mental health and stress management, social awareness etc. are taught by the faculty members. This endeavor helps the students to develop human values, discipline, friendship and care for fellow students of our college.

#### 5. Evidence of Success:

Introduction of Value-Based Education has been reflected on the students by their well-mannered behavior, simplicity and friendliness. Participation of the students as NSS volunteers indicates the fruitfulness of this venture.

#### 6. Problems encountered and Resources Required:

Insufficient teachers, lack of fund and paucity of classrooms are major hurdles to be overcome to make the Value-Based Education successful.

#### **Best Practice 2**

#### 1. Title of the Practice: Help thy Neighbour

#### 2. Objectives of the Practice:

AcharyaSukumarSenMahavidyalaya was established with a view to spread the light of education to the downtrodden, minority and backward section of the rural masses. The college is located in a remote village at the borderline of PurbaBarddhaman district of West Bengal. People of the locality are mostly farmers. During the formative stage of the college people came forward and generously donated money. Some donated land for the college building. Keeping all these in mind the college authority is determined to co-operate with them and let the local schools use the college hall/play ground free of cost for their co-curricular activities.

#### 3. The Context:

By permitting local people to use the college hall/ playground might create a difference among other organizations in the community to establish a stronger bond between the local people and the college students. The first step is to take initiative for the benefit of the local people. The college has tried to establish collaborations with the local high schools/free primary school/local clubs etc. to allow them to use the college hall/ playground for their sports / cultural events or drawing competitions etc.

#### 4. The Practice:

In order to foster collaboration between local bodies and the institute a number of initiatives have been taken by the college in recent years. The following are some of the practices that can be worth mentioning.

- Use of college ground: The college has allowed local clubs and primary schools to use the college ground and other facilities for sports and cultural events. This will not only benefit the local people to conduct their activities but will also provide our college students a scope to tie up the local community with a stronger relationship.
- Use of college hall: The college has offered its hall (carpet area 2850 sqft) to the local Gotan Sree Sree RamakrishnaSaradamoni Ashram and Primary schools to conduct their programmes. Students of the institution show honesty and integrity in all sorts of academic affairs. The institution organizes seminars, webinars, workshops and counseling programmes on regular basis to inculcate mental alertness and social responsibility among the

students. Regular programmes are also organized in the college on various social and environmental issues. Almost seventy percent students of this co- educational institution are females. Keeping it in mind our college has taken several steps by organizing a number of counseling programmes on various aspects of gender equity to make the students alert on the importance of gender balance and necessity of woman empowerment. In order to foster social responsibility and community engagement among the students our college has organized a number of outreach programmes. The NSS unit of the college has extended its activities in neighbouring areas so that the volunteers are motivated to inculcate the spirit of social commitment and develop co-operative mindset. Our NSS unit has adopted a local village where special camps are held. IQAC in collaboration with the NSS unit of the college has organized blood donation camp during which a number of local people also donated blood. During COVID-19 pandemic, two days vaccination camp were organized In our campus. A free cold drinking water station has been set up within the campus which supplies pure drinking water not only to our students but is also accessible to the local farmers who are used to collect drinking water throughout the year. Our college has organized Thalassemia Awareness Programme in which our Principal DR. J. K. Mukherjee was the resource person. Dr. Mukherjee explained the genetics of the disease in a very lucid manner and gave importance on necessity of awareness of the common people.

Our Value Based Education effort is aimed at imparting moral values among the students. In fact, morality in today's decaying society is of utmost importance and should essentially be practised at undergraduate studies. For this reason, masterminds of our Value Based Education Programme have categorically selected topics on moral values, dignity of labour, discipline and time management, mental health etc. for first semester students of the college. Our institution has framed a unique code of conduct which is hoisted in the college website and it is formulated to guide the students for what to do and what are not to do. A committee regularly monitors the overall performance of the students to maintain the campus environment healthy and sustainable to all our stakeholders. Our Principal and faculty members deliver talks on topics related to Value Based Education. The institution organizes an induction programme every year for first semester students in which they are made aware of the code of conduct. Parents and guardians are also made familiar with the code of conduct at the time of parent- teachers' meet.
